#### **PURPOSES**

The Accreditation Commission of the Asia Pacific Theological Association (APTA) exists for the purpose of assisting member institutions voluntarily assess their effectiveness in accomplishing their mission and ministry training goals. The process of accreditation requires a self study and on-site visit for validation purposes.

The Accreditation Commission has also established a procedure for schools to obtain endorsed status. Member schools may apply for endorsed status as a step between membership and accreditation. The qualifications for and terms of endorsed status are determined by the Accreditation Commission. Endorsed schools have not been accredited and may not represent themselves as accredited, but are making progress toward candidate status, including the initiation of a self-study."

Through these processes of continuing institutional self renewal aided by self study and evaluation, the APTA Accreditation Commission seeks to accomplish two essential purposes:

- Purpose 1 To assure an institution and its constituency that the school has established and is substantially accomplishing its mission, goals and objectives.
- Purpose 2 To encourage a school to upgrade its instructional program and support services, and to continue to focus on Pentecostal distinctives and the importance of learning and training for effective ministry.

## **QUALIFICATIONS FOR ENDORSED STATUS**

- A. Basic qualifications for endorsement are the same as for candidate status for schools pursuing accreditation.
  - 1. Membership in APTA.
  - 2. Five years in operation or two graduating classes.
  - 3. Appropriate authority to operate as a school.
  - 4. Possession of a structured curriculum.
  - 5. Having a governing body with legal responsibility for the school.
  - 6. Possession of the basic resources necessary to implement the curriculum (i.e. administrators, faculty and physical facilities).

#### B. Additional requirements related to Standards

 Mission Statement: There is a written constitution stating the mission/ purpose of the school and a statement of the goals and objectives of the school.

#### 2. Academic

- a. There is an appropriate sequence of courses leading to the certificates, diplomas or degrees awarded that follows the APTA standards for such awards in terms of credit hours.
- b. The curriculum gives emphasis to Pentecostal/Charismatic distinctives.
- c. Appropriate transcripts are maintained for students.
- 3. **Faculty:** Faculty have appropriate training for the courses they teach (most faculty hold a degree at least one level higher than they teach or hold appropriate professional certification).
- 4. **Student Services:** There is evidence of attention to student needs.
- 5. **Learning Resources:** There are resources (e.g. library, online sources, etc) to support the training offered.

#### 6. Governance

- a. The governing body meets at least annually.
- b. There is a president/principal/director and an academic officer with appropriate responsibilities as detailed in their job descriptions.
- 7. **Physical Resources:** The facilities are adequate for the classes and programs offered.

- 8. **Financial Resources:** There is an annual financial plan and evidence of sufficient resources for the continued operation of the school.
- 9. **Student Outcomes:** Most graduates are engaged in ministry.
- 10. **Relationships with Churches:** The school has a church constituency that it serves.

#### PROCEDURE TO OBTAIN ENDORSED STATUS

- A. The school applies for endorsed status by submitting the required basic documentation (A), and indicating their compliance with items related to the APTA Standards (B).
- B. An Accreditation Commission representative visits the school to ascertain their qualifications and makes a recommendation to the Accreditation Commission regarding granting of Endorsed Status.
- C. The school agrees to initiate a self-study within five years (Asia Pacific Education Office [APEO]/APTA personnel may be available to provide consultation and give assistance).
- D. The Commission grants Endorsed Status for a period of three years or advises the school on the steps needed to achieve endorsement. Endorsed status may be renewed if the school is demonstrating progress toward initiating a self-study. Endorsed schools may apply to APTA for financial and administrative assistance to conduct a self-study.
- E. Endorsed schools submit annual reports indicating progress toward a self-study.
- F. Endorsed schools may apply to the APTA School Development Grant Program for a grant of up to \$2500 for expenses related to preparing for or conducting a self study.

# MOVING FROM ENDORSEMENT TO ACCREDITATION

While Endorsed Status provides a valuable level of recognition for a school, it is not intended to be the terminal level of recognition. Thus, endorsed schools have committed themselves to undertake a full self-study and pursue accreditation within a five-year period. The APTA Guide to Accreditation provides information on APTA process of accreditation and how to conduct a self study.

Endorsed status is granted for an initial period of three years and may be renewed for an additional period of three years if progress is being made toward conducting the self-study. APTA and APEO personnel are available to consult with a school during this process.
